The price for participation is \$45 per 6-foot table space. A space will be approx. 8 x 8 ft. area and will fit one 6-foot table, two chairs and space for vendors and customers to move around easily within the rows.

You need to bring your own table/setup. Vendors are required to keep their product within the designated area.

For use of an electrical outlet, add an additional \$10

Application fees are Non-Refundable. (Checks will be returned for any application not accepted.). Notification will be made as soon as all applications have been reviewed. For returned checks a \$25 fee will be charged. Table assignments are made based on the order in which we have received vendor applications.

All vendors, or vendor representatives, are required to be present throughout the open hours of the entire boutique and all vendors must have a California Sellers Permit. (See page two for hours) Vendors will need to supply their own tablecloths. Tablecloths will need to be large enough to hide any extra items under the tables.

It is highly encouraged that a holiday theme be incorporated in your display as well as holiday gift buying be the focus of those products or crafts you bring to sell. Products in all price ranges are recommended.

Each customer will be able to purchase a raffle ticket. Please donate one item in the amount of \$20 to raffle off to our customers at the end of the Boutique. Please include a brochure or business card in the bag.

Set-up is Saturday, November 30, 2024, from 9:00 a.m. - 10:00 a.m. (Boutique opens at 10:00 a.m.)
